**ORDER**

The Hon'ble Kerala Administrative Tribunal, as per its order read as 1st paper above, has disposed of OA no.1295/2019, directing the respondents 1 to 3, i. e., Govt, Chief Engineer and Director of Urban Affairs respectively, to ensure that the pension of the applicant, Sri. Babu P. T, Asst.Exe.Engineer (Rtd), is duly disbursed after rectifying the defects as pointed out by the Accountant General in its communication dated 27.06.2019. It is also directed to ensure that proper entries are made in the Service Book, duly updating the same and his probation declared in Asst.Engineer and Asst.Exe.Engineer cadres and his pay regularised within a period of six weeks from the date of receipt of a copy of the order. The respondents should thereafter ensure that the pensionary benefits due to the applicant is disbursed within a period of three months there from and to ensure that the payments are disbursed within the time limit, failing which the respondents will be liable to pay penal interest at 9% from the last date prescribed for disbursement till the actual disbursement of the same.

2. Consequent to the declaration of probation of the applicant in Asst.Engineer cadre by the Chief Engineer, the proposal for inclusion of his name in the select list for regularizing his provisional promotion to the post of Asst.Exe.Engineer was placed before the Review DPC(H) held on 25.09.2020. The Review DPC(H) after considering the case of the applicant decided to include him as Sl no.45 in the modified select list 2012 for regularisation of provisional promotion of AEE cadre. The select list has been approved vide GO(P)no.63/2020/LSGD dated 04.11.2020. Consequent to this, his provisional service in the AEE cadre was regularised vide GO(Rt)no.445/2021/LSGD dtd 15.02.2021 and thereafter his probation in the AEE



cadre has been satisfactorily declared vide GO(Rt)no.749/ 2021/LSGD dated 23.03.2021.

3. The Chief Engineer, LSGD, vide letter read as 2nd paper above, has reported that all pensionary benefits including DCRG, after withholding an amount of Rs 79,074/-, in connection with the surcharge certificate issued to the retired officer, has been sanctioned to him vide proceedings dtd 05.12.2019. Also, Absolute No Liability Certificate has been issued to the Treasury for disbursing his DCRG.

4. In the above circumstances, as all pensionary benefits due to Sri. P. T. Babu, AEE (Rtd) has been sanctioned and his probation in the cadres of Asst.Engineer and Asst.Exe.Engineer has been satisfactorily declared, the order of the Hon'ble KAT in OA no.1295/2019 read as 1<sup>st</sup> paper above, is hereby complied with.
