**ORDER**

As per G.O read as 1<sup>st</sup> paper above, Government have approved the Request for Expression of Interest (REoI) for publication for the selection of Project Management Consultant for the Kerala Solid Waste Management Project (KSWMP). KSWMP has published REoI for hiring Project Management Consultants (PMC) on 06/08/2020 and the Evaluation Committee constituted vide G.O. read as 2<sup>nd</sup> paper above verified the projects submitted by the firms and found that most of the firms submitted details of projects than what was required in REoI and in most cases the completion and acceptance certificates were not attached. In the circumstance that the projects submitted by the firms were not conforming to the eligibility criteria, as per G.O. read as 3<sup>rd</sup> paper above, Government have directed KSWMP to renotify REoI.

2. As per the note read as 5<sup>th</sup> paper above, the Project Director, KSWMP has reported that, KSWMP re notified the REoI and Evaluation Committee held on 03.02.2021 has recommended shortlisting of the following 8 (Eight) firms for consultancy services for "PMC for Kerala Solid Waste management Project" subject to the approval by World Bank.
