## **ORDER**

As per the letter read as 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> paper above, Ministry of Rural Development, Government of India had sanctioned ₹6,54,59,000/- as General component, ₹7,68,42,000/- as SCP component and ₹5,29,78,000/- as TSP component to State of Kerala towards the 2<sup>nd</sup> tranche of 2<sup>nd</sup> installment of Central Share under NRLM/Ajeevika during the year 2020-21.

- 2) As per the letter read as 5 <sup>th</sup> above, the Executive Director, Kudumbashree has requested to release the aforesaid Central Share along with the corresponding State Share for the above purpose.
- 3) Government have examined the matter in detail and are pleased to accord sanction to the release of a total amount of ₹32,54,65,000/- (Rupees Thirty Two Crore Fifty Four Lakh and Sixty Five Thousand only) to the Executive Director, Kudumbashree being Central Share and its matching State Share of 2<sup>nd</sup> tranche of 2<sup>nd</sup> Installment for implementation of NRLM/ Ajeevika for the FY 2020-21 from the current year budget provision as detailed below:
