ORDER

As per letter read as 1 st paper above an amount of ₹6,85,98,885/- has been sanctioned to the State on account of payment of 1st instalment of Central assistance for financial year 2020-21 towards stipend (Against wage loss compensation) under Projet UNNATI. The Mission Director (MGNREGA), vide letter read as 2nd paper above, has requested to release the Central assistance received urgently.

2. As per the Government order read as 3 rd paper above, sanction has been accorded for opening a new head of account viz.2505-02-101-89-Stipend under Project UNNATI(100 % CSS) in the demands for grants and detailed budget estimates of 2021-22. As per the Government order read as 4th paper above, sanction for authorisation of additional expenditure to the tune of Rs.6,85,98,885/- has been granted under the above head of account.

The Commissioner for Rural Development is authorised to transfer credit the above amount to the bank account maintained at SBI Nanthancode by the Mission Director(MGNREGA) exclusively for Project UNNATI by debiting the head of account 2505-02-101-89.
- 4. The Commissioner for Rural Development shall submit proposal to regularise the expenditure through re-appropriation of savings within the grant before the close of the current financial year.
