#### **ORDER**

The Hon'ble Kerala Administrative Tribunal, as per its order read as 2<sup>nd</sup> paper above, has disposed of OA(EKM) 73/2021 filed by Sri.Omprakash.B.R, directing the 3<sup>rd</sup> respondent, ie the Chief Engineer, LSGD to consider and pass appropriate orders on Annexure A3 appeal, within a period of one month from the date of receipt of a certified copy of the order.

- 2. In the Annexure A3 appeal, read as 1<sup>st</sup> paper above, the applicant, who is presently working as Asst.Exe.Engineer in Balussery Block Panchayath, Kozhikode has requested to transfer and post him in Palluruthy Block Panchayath, as Asst.Exe.Engineer post is lying vacant there.
- 3. In view of the specific direction from the Hon' KAT, the Chief Engineer, vide proceedings read as 3<sup>rd</sup> paper above, has complied with the order of the KAT by stating that authority competent to consider the transfer and postings of Asst.Exe.Engineers is Govt, who is also the authority to consider the appeal of the applicant.
- 4. In the above circumstances, Government have considered the Annexure A3 Appeal preferred by the applicant and found that he was transferred from Kochi Corporation to Balussery Block Panchayath on getting promotion as Assistant Executive Engineer vide GO(Rt)no. 29/2021/LSGD dated 05.01.2021. As merely four months have been elapsed since his joining duty in the present station on getting promotion, his contention in Annexure A3 Appeal is not worth considering and hence

is hereby declined.
