### ORDER

The Director of Panchayat as per order read as first paper above placed Sri.Ummerkoya Kozhikkodan under suspension on the charges of using abusive and filthy language towards a lady who belongs to SC/ST Community. Based on the above illegal activities of the accused a crime case bearing no. 55/2020 U/s 509 IPC & 3(2) V a of SC/SC Act had been registered against the applicant herein. Later the applicant filed O.A (EKM) No. 1755/2020 before the Hon'ble Kerala Administrative Tribunal against the continuance of the suspension and the Hon'ble Tribunal ordered as noted below;

"......... The applicant has been continuing under suspension for more than one year and he has less than two months to retire from service. His suspension was only to enable the smooth conduct of the investigation and taking possession of the relevant records from the Panchayat Office. It is stated that the investigation of the case is not over and the applicants submits that no records from the Panchayat Office have been taken in to custody so far. There is no justification in continuing the suspension of the applicant, especially when he is due to retire with in two months.

The first respondent is directed to reinstate the applicant in

service within two weeks. It will be open to the respondents to post the applicant outside Malappuram District and insist that he shall not be posted back to Malappuram District."

Government examined the matter and are pleased to direct the Director of Panchayat to reinstate Sri.Ummerkoya Kozhikkodan, in service, as the order of suspension was issued by that authority by adhering to the condition specified by the Hon'ble K A T.

The direction issued by the Hon'ble K A T is complied with accordingly.
