## **ORDER**

As per the report of the 10th Pay Revision Commission, the Director of Urban Affairs has submitted the recommendation to implement the Pension Revision of the employees of the Electricity Wing of the Thrissur Corporation. Government have examined the matter in detail and considering the pension revision in the Kerala State Electricity Board in connection with the report of the 11th Pay Revision Commission which is expected to be issued soon, Government are pleased to revise the pension of the employees of the Electricity Wing of the Thrissur Corporation with effect from 01/07/2013 as follows;

- The minimum basic pension/family pension is enhanced from Rs.4,100/- to Rs.8,500/- per month (After merger of 84.253% of Dearness Relief).
- The maximum pension shall be Rs.58,040/- per month (ie, 50% of the maximum of the highest scale of pay in Thrissur Corporation Electricity Department Rs.1,16,080/-)
- The maximum family pension (normal rate) shall be Rs.34,825/- per month (ie, 30% of the maximum of the highest scale of pay in Thrissur Corporation Electricity Department Rs.1,16,080/-)

• From 01.07.2013/01.08.2013 (Others/Workmen as the case may be) the pensioners shall get Dearness Relief (After merger of 84.253% of Dearness Relief) as follows

- Fitment Benefit @ 18%, Dearness Relief @ 84.253% shall be merged with Existing basic pension as on 30.06.2013/31.07.2013.
- The gratuity shall be given as per the provisions of the Payment of Gratuity Act 1972, subject to a maximum amount of Rs.10,00,000/- only.
- The pension revision proposal shall come into effect from 01/07/2013.

The pension arrears of the employees of the Thrissur Corporation Electricity Wing should be paid under the following conditions similar to the arrears paid as the pension revision sanctioned in the Kerala State Electricity Board.

- ▶ The arrears on pension revision should be paid in three instalments in May 2021, November 2021 and May 2022.
- The pension arrears of pensioners and family pensioners who have attained the age of 75 years on the order date should be paid as a single instalment along with the pension of June 2021.
- The additional financial liability of Rs 3 crore incurred in this connection should be met from the General Purpose Grant allotted to the Thrissur Muncipal Corporation.
