**ORDER**

Government of India have formulated a Scheme Project UNNATI with the intention to upgrade the skill base of the Mahatma Gandhi NREGA workers and thereby improve their livelihood and also with an objective to uplift them from the current partial employment to full employment and to reduce their dependence on Mahatma Gandhi NREGS. Under this project, one adult member of a household who have completed 100 days of work under Mahatma Gandhi NREGA during the financial year 2018-19 will be provided training through Rural Skill Division of Ministry of Rural Development and Krishi Vigyan Kendras of Ministry of Agriculture.

The other salient features of the scheme are:

1. The household from which a candidate will be selected for the training will continue to enjoy 100 days of work under Mahatma Gandhi NREGA.
2. A family member of eligible household in age group of 18-35 years will

be eligible for training under DDU-GKY. In case of special groups, the age group shall be up to 45 years as per DDU-GKY guidelines. For RSETI and KVKs, a family member of eligible household in the age group of 18-45 years will be eligible.

3. The candidate undergoing training will be paid stipend for a maximum period of 100 days and for one program per household as per the prevailing wage rate.
4. The candidate shall be eligible for getting stipend if the candidate has attended at least 75% of the training classes or the course attendance requirement, whichever is more. This will be calculated each fortnight.
5. SRLM will submit the attendance of the candidate once every 15 days on the web based MIS created for the purpose.
6. The stipend to the trainees will be made on receipt of the attendance through web portal, as per the Project protocol, by generating FTOs under Material Head (Capacity Building and Technical Support Component) fund.
7. All the candidate shall be registered through Kaushal Panjee app.

2. As per letter read as 1<sup>st</sup> paper above, an amount of ₹6,85,98,885/- has been sanctioned to the State on account of payment of 1<sup>st</sup> instalment of Central assistance for financial year 2020-21 towards stipend (Against wage loss compensation) under Project UNNATI. As per the Government order read as 2<sup>nd</sup> paper above, the Commissioner for Rural Development was authorised to transfer credit the above amount to the bank account maintained by the Mission Director(MGNREGA) exclusively for Project UNNATI.

3. As per the letter read as 3<sup>rd</sup> paper above, Mission Director (MGNREGA) has submitted a proposal and requested to accord Administrative Sanction for the implementation of Project UNNATI in the State. As per the proposal a total number of 6548 beneficiaries will be provided training under DDU-GKY/RSETI and KVK. The State Rural Livelihood Mission in the State i.e Kudumbasree Mission is entrusted with the selection of beneficiaries under the Project UNNATI for the training provided

free of cost.

4. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the implementation of Project UNNATI in the State, utilizing an amount of ₹6,85,98,885/- received as 1<sup>st</sup> instalment of Central assistance from MoRD, Government of India. The selection of beneficiaries under the Scheme shall be in adherence to the criteria prescribed in the Guidelines of Project UNNATI issued by Government of India.
