### ORDER

Pradhan Mantri Grama Sadak Yojana (PMGSY) is an ongoing Centrally Sponsored Scheme and Government of Kerala provide an additional State support to the Scheme. The major components of Additional State share to be met by State include fund towards routine maintenance, tender premium over and above estimate cost, shifting of utility and maintenance of PMGSY roads which have completed defect liability period. An amount of Rs. 2000 lakh is earmarked for this purpose in the Annual Budget 2021-22 under the H/A 45 15-00-800-98. The component wise details of the State Plan scheme are as follows:-
