ORDER

Government of India introduced a Special Micro-credit facility scheme, PM Street Vendor's Atma Nirbhar Nidhi (PM SVANidhi) for urban street vendors to mitigate the hardships faced by them due to COVID-19 pandemic. The scheme will help link the street vendors with the formal financial institutions and will open up new opportunities to this sector to move up in the economic ladder.

- (2) More regular and organised co-ordination is required among the stake holders for speedy implementation of the scheme and delivering scheme benefits without delay. As per section 19(b) of the Scheme Guidelines, referred as 1st paper above, a Committee under the Chairmanship of Principal Secretary of Urban Development / Municipal Administration needs to be constituted for effective implementation of the scheme. The committee needs to meet at least once in every three month for effective implementation and monitoring of the scheme in the State.
- (3) As per letter read as 2 nd paper above, Executive Director, Kudumbashree has requested to constitute a Monitoring Committee for effective implementation of the of PM SVANidhi Scheme.
