### **ORDER**

The Department of Expenditure, Ministry of Finance, Government of India has implemented Public Financial Management System (PFMS) - a web-based online software application with the objective of tracking funds released under all plan schemes of Government of India and real time monitoring and reporting of expenditure at all levels of programme implementation. In compliance with the guidelines issued by Government of India in this regard, it has been instructed, as per the Circular read as 2<sup>nd</sup> paper above, that the Administrative Department concerned is to designate a Single Nodal Agency (SNA) for implementing each Centrally Sponsored Scheme (CSS) and the SNA will open a Single Nodal Account for each CSS at the State level in a Scheduled Commercial Bank authorized to conduct Government business.

2. As per the letter read as 3<sup>rd</sup> paper above, the Mission Director(MGNREGS) requested that appropriate orders may be issued to designate Mahatma Gandhi NREGS State Mission as the Single Nodal Agency (SNA) for implementing Mahatma Gandhi NREGA in the State.


3. Government, after having examined the matter in detail and also in the
