ORDER

As per reference 1st cited, Government have accorded Administrative Sanction for an amount of Rs.3500 Lakh, for the paln scheme of Suchitwa Mission- Suchitwa Keralam (Rural) under the H/A- 2515-00-101-68. Pre monsoon cleaning activity (Arogya Jagratha Campaign) is one of the components under this scheme.

- 2) As per reference 2nd cited, the Executive Director, Suchitwa Mission has reported that funds related to pre monsoon cleaning campaign has to be transferred to Grama panchayats (Rs.10000/- per ward in each Grama panchayat) and other committed liabilities has to be cleared at the earliest. The Executive Director, Suchitwa Mission has requested to release an amount of Rs. 3500 Lakh for the paln scheme of Suchitwa Mission- Suchitwa Keralam (Rural) under the H/A- 2515-00-101-68.
- 3) Government have examined the matter in detail and are pleased to issue orders to release an amount of Rs.1597 Lakhs (Rupees One Thousand Five Hundred and Ninety seven lakh only) from the head of account "2515-00-101-68 (Suchitwa Keralam-Rural)" for the paln schemes of Suchitwa Mission- Suchitwa Keralam (Rural). The Executive Director, Suchitwa Mission has to submit UC for previous releases from the head of account and details of other committed liabilities/anticipated expenditure for further release of funds.
