ORDER

1.As per Government Order read 1st above, Government have constituted State Project Management Unit (SPMU) for implementing World Bank assisted Kerala Solid Waste Management Project. The State Project Management Unit of KSWMP is housed in the 4th floor of Trans Towers, Vazhuthacaud in an area having an extent of 1190 sq. feet.

- 2. As per the order read as 2nd paper above, sanction was accorded to shift the State Project Management Unit (SPMU) of KSWMP from 4th floor of Trans Towers Vazhuthacaud to ground floor of CALSAR, Heather Tower, Punnen Road, near Government Secretariat for rent approved for functioning of Rebuild Kerala Initiative (RKI) in the same building.
 - 3. The Project Director, KSWMP as per the letter read as 3 rd

paper above, has now submitted a new proposal for according sanction to shift the State Project Management Unit (SPMU) of KSWMP from 4th floor of KTFDC Trans Towers to 3rd floor of KTDFC Trans Towers with an area of 5316sq.ft available for rent at the rate of Rs.59.5 per Sq.ft as they were informed from CALSAR Heather towers that space alloted for the state project unit of KSWMP has been leased to some others as the office was not able to execute the agreement with the owners before the issuance of Government Order. The Project Director, KSWMP has also requested to accord sanction to perform interior works in the space and to ratify the action in requesting KTDFC for allotment of space without prior sanction.

4.Government have examined the matter in detail and are pleased to accord sanction to to shift State Project Management Unit (SPMU) of Kerala Solid Waste Management Project (KSWMP) from 4th floor of KTFDC Trans Towers to 3rd floor of KTFDC Trans Towers with permission to perform interior works. The action of the Project Director, KSWMP in having requested the KTDFC for allotment of space without prior sanction is also ratified.
