ORDER

Shri.S.J.Jayakumar ,Sub Engineer (Rtd) and 4 other retired employees of Thrissur Corporation Electricity Wing filed OA (EKM) 782/2020 for sanctioning all benefits as per the pay revision order GO(Ms)No.184/2018/LSGD dated 12.12.2018 implemented in the Thrissur Corporation Electricity Wing. Applicants 1 to 3 and 5 are retired Sub Engineers and the 4th respondent is Driver.

The Hon'ble Court in the order dated 14.12.2020 in OA (EKM) 782/2020, directed the 6th respondent (Secretary, LSGD) to consider and pass appropriate orders on Annexure A5 representation in accordance with law, within a period of three months from the date of receipt of copy of the order.

As per GO(Ms) No. 184/2018/LSGD dated 12.12.2018, Government accorded sanction to revise the pay and allowances of the employees in

Thrissur Corporation Electricity Wing in tune with the pay revision orders issued by the Kerala State Electricity Board. As per this order the scale of pay of workmen and the category of employees in the Thrissur Corporation Electricity Wing was revised with effect from 01.08.2013. The petitioner have alleged that they didn't get the revised salary and pension at the revised rate till date as they were in service as on 01.08.2013.

The Director of Urban Affairs is the authority for fixing of revised pay and allowances, disbursement of salary and arrears in respect of the employees in Thrissur Corporation Electricity Wing as per the Pay Revision Order.

The Director of Urban Affairs, vide letter read 3rd above, informed that the Thrissur Corporation Secretary has reported that the Pay in respect of Shri.S.J. Jayakumar, Sub Engineer (Rtd) (the petitioner in OA) has been revised and the Service Book in respect of him has been forwarded to Kerala State Audit Department for revising the Pension and the revised verification report has been received from the Kerala State Audit Department for revising the Pension as per the letter no DKSA/16972021-Pen-2 dated 18/08/2021 and urgent action is being taken in the concerned Corporation to disburse the pension as per the order of Hon'ble Tribunal.

The order dated 14.12.2020 in OA (EKM) 782/2020 of the Hon'ble KAT is hence complied with.
