### ORDER

The Secretary, State Election Commission, vide reference cited 1 above, had informed that the Head Quarters of State Election Commission was shifted to its newly built multi-storeyed building situated at the far end of the Vikas Bhavan Compound, Thiruvananthapuram. The Commission needed to store High Security Electronic Voting Machines and allied paper seals in the new building in connection with the General Elections to local body institutions. Also, the furniture shifted from the old office of the Commission are kept in the new building's basement till those are auctioned, if found surplus. Further the new building has ultra modern amenities like high end Projectors, Public Address System and Conferencing set up with Video Conferencing facility. In these circumstances, round the clock security measures are required in the State Election Commission and the Commission engaged one more watchman with effect from 01.08.2020 in addition to the watchman in the sanctioned post from M/s. Travancore Force Security Solutions, "Regi Manzil", TC-181/1382, Deshabhimani Road, Pulimood Post, Thiruvananthapuram at a monthly salary of Rs.14,500/- for attending to day duty in the

Commission and subject to ratification of Government.

The Secretary, State Election Commission has now requested to ratify the action of the State Election Commission, Kerala in having appointed the additional watchman to the State Election Commission, Kerala on contract basis for a period of one year with effect from 01.08.2020.

Government have examined the matter in detail and are pleased to ratify the action of the State Election Commission, Kerala in having appointed the additional watchman from M/s. Travancore Force Security Solutions, "Regi Manzil", TC-181/1382, Deshabhimani Road, Pulimood Post, Thiruvananthapuram to the State Election Commission, Kerala on contract basis at a monthly salary of Rs.14,500/- for attending to day duty for a period of one year with effect from 01.08.2020.
