ORDER

As per the reference Ist cited, Government introduced Electronic Ledger Account (ELA) System facilitating Government departments/PSUs to ensure efficiency and continuity in utilisation of funds.

- 2. As per the reference 2nd cited, Government issued administrative sanction for the Modernisation, Computerisation and Capacity Building programmes in LSGD Engg Wing, for an amount of Rs 2,25,00,000/-(Rupees Two Crores Twenty Five lakhs only), earmarked under the Head of Account '2515-00-001-86-34-03-other items (PV)' for the year 2020-2021. Since the sanctioned amount could not be expended in full during the last financial year, Government vide reference third cited have permitted to post an amount of Rs 1,31,78,000/- (Rupees One Crore Thirty One Lakhs Seventy Eight thousand only) to the Electronic Ledger Account (ELA).
- 3. As per the reference 4th cited, the Chief Engineer, LSGD has requested to release the amount posted in eLAMS for the implementation of the above components of the scheme.
- 4. Government therefore accord sanction to release an amount of Rs 1,31,78,000/- (Rupees One Crore Thirty One Lakhs Seventy Eight thousand only) for the implementation of the above components of the scheme.
- 5. The expenditure will be met from the budget provision under the head of account '2515-00-001-86-34-03-other items (PV)' during the financial year 2021-22.
