ORDER

Sri. Sajish. R, Executive Engineer has filed OA 927/2021 before the Hon'ble Kerala Administrative Tribunal praying for a direction to promote him as Superintending Engineer at the earliest. The KAT as per its order read as 1st paper above, has disposed of the OA directing the 1st respondent, ie Govt to convene a review DPC and to consider the eligibility of the applicant for inclusion in the select list for promotion to the cadre of Superintending Engineer against the existing vacancies.

2. The applicant was superseded by the Departmental Promotion Committee (Higher) 2020 due to the pendency of disciplinary action for minor penalty against him in Govt file no.EW1/388/2017/LSGD in connection with the irregularities in the issuance of building permit. Subsequently the disciplinary proceedings was finalised by awarding him censure vide GO(Rt)no.656/2021/LSGD dated 04.03.2021.

3. Accordingly, the Review DPC(H) 2020 held on 13.07.2021 considered the eligibility of the applicant for promotion to the post of Superintending Engineer and decided to include him in the modified select list 2020 as Sl. No. 5(b) & Rank No. 31. The modified select list was notified vide GO(P) no.37/2021/LSGD dtd 10.08.2021. Consequently, the applicant was promoted to the cadre of Superintending Engineer and posted as such in LSGD North Circle, Kozhikode in the existing vacancy, vide GO read as 2nd paper above.

4. In the above circumstances, as the applicant has been promoted to the cadre of Superintending Engineer, order of the Hon' KAT in OA 927/2021 is thus complied with.
