ORDER

As per the letter read as 2nd paper above, the Mission Director, AMRUT has informed that five proposals related to Water Supply Sector works of Thrissur Corporation was placed in the 28th SHPSC for approval and the Committee decided as follows:

Name of Work: Replacement of very old 80/100/125/200/300 mm AC pipes with 160 mm PVC & 200/300 mm D1 pipes at various places in Thrissur Corporation.

AS Details: Rs.12.95 Cr., vide G.O (Rt) No. 3530/2017/LSGD Dated 02.11.2017.

Reason: Additional amount is required due to tender excess.

Decision: (1) The Committee decided to accord sanction to revise the AS of the work from Rs.12.95 Cr. to Rs.13.79 Cr. subject to the condition that 50% of the tender excess shall be met by the ULB and the balance 50% shall be met by the State.

(2) The work to be completed by 31.12.2021.

(3) Project Manager - Sri. E N Surendran, Executive Engineer, PH Division, KWA Thrissur.

Name of Work: Completion of on-going Schemes – UWSS to Ollur & Edakkunni Census Town Villages in Thrissur Corporation – Construction of 20LL capacity OHSR at Ollur & supplying, laying distribution lines & construction of retaining wall at WTP, Arattupuzha. AS Details: Rs.11.40 Cr., vide G.O (Rt) No. 534/ 2017/LSGD Dated 23.02.2017.

Reason: Additional amount is required due to increase in road restoration/ utility shifting charges, increase in the retaining wall quantity and tender excess.

Decision: (1) The Committee accorded sanction to revise the AS of the work from Rs.11.40 Cr. to Rs.13.96 Cr. subject to the following conditions:

- 50% of the tender excess shall be met by the ULB & the balance 50% shall be met by the State.
- The additional financial commitment due to road restoration charges & additional works shall be met from the available savings in the work namely, “Construction of 20 MLD WTP, Peechi, Thrissur Corporation (SAAP 2015-16 & SAAP 2016-17)”.

(2) The work to be completed by 31.12.2021.

Name of Work: AMRUT – Zoning & mapping of water supply system of Thrissur Corporation – Supply & laying of various diameter pipes – Part-1.

AS Details: Rs.8.00 Cr., vide G.O (Rt) No. 5/ 2018/ LSGD Dated 01.01.2018.

Reason: Additional amount is required due to tender excess.

Decision: The Committee decided to ratify the action taken by KWA in awarding the work at 22.02% tender excess and accorded sanction to revise the AS of the work from Rs.8.00 Cr. to Rs.8.52 Cr. subject to the condition that 50% of the tender excess shall be met by the ULB & the balance 50% shall be met by the State.

Name of Work: AMRUT – Zoning & mapping of water supply system

of Thrissur Corporation – Supply & laying of various diameter pipes – Part-2.

AS Details: Rs.17.00 Cr., vide G.O (Rt) No. 5/ 2018/ LSGD Dated 01.01.2018.

Reason: Additional amount is required due to tender excess.

Decision: (1) The Committee decided to accord sanction to revise the AS of the work from Rs.17.00 Cr. to Rs.17.71 Cr. subject to the condition that 50% of the tender excess shall be met by the ULB & the balance 50% shall be met by the State.

(2) The work to be completed by 31.10.2021.

(3) Project Manager - Sri. Jayaparakash P, Executive Engineer, Project Division, KWA Nattika.

Name of Work: Construction of 5LL OHSR at Kuttanallur with gravity main & distribution network.

AS Details: Rs.8.00 Cr., vide G.O (Rt) No.3530/ 2017/ LSGD Dated 02.11.2017.

Reason: Additional amount is required due to increase in road restoration charges / utility shifting charges, tender excess and amount required for pile foundation.

Decision: (1) The Committee accorded sanction to revise the AS of the work from Rs.8.00 Cr. to Rs.9.05 Cr. subject to the following conditions:

- 50% of the tender excess shall be met by the ULB & the balance 50% shall be met by the State.

- The additional financial commitment due to road restoration charges & additional works shall be met from the available savings in the work namely, “Construction of 20 MLD WTP, Peechi, Thrissur Corporation (SAAP 2015-16 & SAAP 2016-17)”.

(2) The work to be completed by 31.10.2022.

(3) Project Manager - Sri. Jayaparakash P, Executive Engineer, Project Division, KWA Nattika.

Completion of on-going Schemes – UWSS to Ollur & Edakkunni Census Town Villages in Thrissur Corporation – Construction of 20LL capacity OHSR at Ollur & supplying, laying distribution lines & construction of retaining wall at WTP, Arattupuzha from Rs.11.40 Cr. to Rs.13.96 Cr. subject to the conditions that 50% of the tender excess shall be met by the ULB & the balance 50% shall be met by the State. Also to ratify the action taken by KWA in awarding the work at 22.02% tender excess.
4. AMRUT – Zoning & mapping of water supply system of Thrissur Corporation – Supply & laying of various diameter pipes – Part-2 from Rs.17.00 Cr. to Rs.17.71 Cr. subject to the condition that 50% of the tender excess shall be met by the ULB & the balance 50% shall be met by the State and the work to be completed by 31.10.2021 by Project Manager - Sri. Jayaparakash P, Executive Engineer, Project Division, KWA Nattika.
5. "Construction of 5LL OHSR at Kuttanallur with gravity main & distribution network" from Rs.8.00 Cr. to Rs.9.05 Cr. subject to the conditions that 50% of the tender excess shall be met by the ULB and the balance 50% shall be met by the State and the additional financial commitment due to road restoration charges and additional works shall be met from the available savings in the work namely, “Construction of 20 MLD WTP, Peechi, Thrissur Corporation (SAAP 2015-16 & SAAP 2016-17)”. Also the work to be completed by 31.10.2022 by Project Manager - Sri. Jayaparakash P, Executive

Engineer, Project Division, KWA Nattika.
