ORDER

Shri. B Reghu Kumar has filed a WP(C) No.10238/2018 before the Honble High court, in connection with payment pending with the road work done by him on a contract awarded by Thiruvananathapuram Thiruvananthapuram Corporation. As the Municipal Corporation had taken a stand before the Honourable Court that the work had not been completed by the petitioner as affirmed by him, as per order read above it was directed to conduct an enquiry through the Vigilance Wing of LSGD and to submit a report before the Court by the fourth Respondent (the State of Kerala represented by Secretary to Government, LSGD). The Honble Court has also directed to give sufficient opportunity to the petitioner as well as the Municipal Corporation in the proceedings. The Honble Court has directed to ensure the compliance of Court order and to submit report of compliance 30.10.2021.

2.Government are pleased to authorize Chief Town Planner (Vigilance), Vigilance Wing, Local Self Government Department to conduct an enquiry through by giving sufficient opportunity to the petitioner as well as the Thiruvananthapuram Municipal Corporation in the proceedings, and submit the report to Government within 22.10.2021 so as to enable Government to file the report in compliance with the

orders of Honble High Court.

3. Chief Town Planner (Vigilance), Vigilance Wing, Local Self Government Department may seek assistance of competent officers from LSG (Engineering Wing) Department to conduct enquiry, if necessary. Chief Engineer, LSG (Engineering Wing) Department shall take immediate necessary action ensure the service of competent officers in the enquiry to be conducted, on the request of Chief Town Planner (Vigilance), Vigilance Wing, Local Self Government Department.
