ORDER

The Kerala Administrative Tribunal as per its order read as 2nd paper above, has disposed of OA(E) 503/2019 by directing the 5th respondent, ie Assistant Executive Engineer, LSGD Sub Division, Pulikkeezhu Block to forward Annexure A5 representation, read as 1st paper above, if not already done, through proper channel to the first respondent, ie Government within a period of three weeks from the date of receipt of a copy of the order and on receipt of such representation, the first respondent shall consider the same and pass appropriate orders within a period of three months from the date of receipt of the same.

- 2. In the Annexure A5 representation which is addressed to the Asst.Exe.Engineer, Pulikeezhu BP, Pathanamthitta, the applicant who retired from service on 31.07.2014 has urged to sanction him 3rd TBHG promotion and to release his salary arrears towards 2014 pay revision as well as terminal surrender of earned leave. But, the Annexure A5 representation has not yet been received in Government.
- 3. On the request of the applicant in Annexure A5, the Chief Engineer, vide letter read as 3rd paper above, has reported that the arrears of salary, leave surrender and Terminal Leave surrender due to the applicant has been disbursed excluding the pay revision arrears for the month of July 2014 only (ie the month of his retirement). The Pay revision arrears for the month of July 2014 could not be processed in SPARK due to some technical issues as the Terminal Surrender was encashed through the Head of Account of salary instead of the Head of Account of Terminal Surrender, due to which

the encashment details has not been updated in SPARK and SPARK office has been communicated to resolve this issue and the salary arrears can be disbursed once these technical issues are rectified.

- 4. In the above circumstances, the grievance of the applicant in Annexure A5 representation has been resolved, except that of salary arrear for one month, which has been attributed to the technical snag in SPARK. Hence, the Chief Engineer is hereby directed to resolve these issues in SPARK and to release the salary arrear in respect of the applicant for the month of July 2014, forthwith.
- 5. The orders of the Hon'ble KAT in OA(E) 503/2019 read as 2nd paper above, is complied with accordingly.
