**ORDER**

As per GO read as 1<sup>st</sup> paper above Government have approved the Project Implementation manual (PIM) for KSWMP. The Project envisages to release funds as Basic Grant and Incentive Grant to the ULBs. Basic Grants will be 40% and remaining 60% will be allocated as Incentive Grants. As per the Project Implementation Manual of KSWMP, the ULBs who have signed participation agreement will be informed of their Grant Allocation Ceiling (GAC) for the project period during the inception stage so as to enable them to prepare 5-year solid waste management plans. However the Grant Allocation Ceiling (GAC) may vary in year 2 and year 4 of the project . Grants will be provided to ULBs through a two-tranche system as per the eligibility criteria ie; Basic Grants and Incentive Grants. Incentive Grants categorised into Track I and Track II activities.

2. The Project Director as per the letter read as 2<sup>nd</sup> paper above has reported that the State Project Management Unit of KSWMP have initiated ground works with respect to allocation of KSWMP funds to the ULBs. As part of this, Track I activities of the Project have been shared with selected ULB for collating their investment proposals in accordance with the aforesaid Track I activities outlined in Project Implementation Manual (PIM). For

preliminary screening of the proposals received from ULBs, the Project Director, KSWMP has requested to constitute a Project Screening Committee with the following officials :

- i. Project Director, KSWMP- Chairman.
- ii. Director of Urban Affairs-Member.
- iii. Deputy Project Director, KSWMP-Member Convenor.
- iv. Solid Waste Management Expert, Suchitwa Mission- Member.
- v. Urban Sanitation & Technical Expert, KSWMP-Member.
- vi. Representative from Haritha Keralam Mission

3. Government have examined the matter in detail and are pleased to constitute a Project Screening Committee with aforesaid officials for screening the investment proposals submitted by the ULBs in accordance with the Track I activities outlined in the Project Implementation Manual (PIM) of Kerala Solid Waste Management Project.


