ORDER

As per Government Order read as 3rd paper above, Government have constituted District Project Management Units (DPMUs) - 14 Nos. and Project Implementation Units (PIUs) in 93 ULBs across Kerala for the implementation of the World Bank - AIIB aided Kerala Solid Waste Management Project (KSWMP).

2. As per letter read as 4th paper above, Project Director, Kerala Solid Waste Management Project (KSWMP) has informed that the State Project Management Unit (SPMU) is already functional and is currently completing all non-major procurements and necessary groundwork and resource-mapping that will be required when the project begins its full-fledged implementation. Since the Project Agreement with the World Bank - AIIB and the DEA has to be executed by November, 2021 the DPMUs and PIUs need to be constituted urgently as it is a mandatory requirement that needs to be fulfilled prior to the execution of Project Agreement. Notification for the post of District Co-ordinator / Solid Waste Management (SWM) Engineer - 14 Nos., Financial Management Expert - 14 Nos. and Solid Waste Management Engineer-17 Nos. has been issued on 13.10.2021.

3. Project Director, KSWMP has requested to accord sanction for availing the services of Centre for Management Development (CMD) for short listing the CVs received with respect to the recruitment of staff in District Project Management Units (DPMUs) and Project Implementation Units (PIUs) of KSWMP and informed that the expenditure in this regard can be met from the funds available with Kerala Solid Waste Management Project. The World Bank in their Aide Momoire of their Mission held during 6-10 September 2021 has also recommended the service of CMD for extending the procurement packages of the project.

4. Government have examined the matter in detail and are pleased to accord sanction for availing the services of CMD for shortlisting the CVs received with respect to the recruitment of staff in District Project Management Units (DPMUs) and Project Implementation Units (PIUs) of KSWMP. The expenditure in this regard can be met from the funds available with Kerala Solid Waste Management Project. Sanction is also accorded for allowing KSWMP to utilise the service of CMD for the scrutiny of all further procurement packages, in case of necessity.

5. The final selection will be through the committee constituted for the recruitment, vide Government Orders read as 1st and 2nd paper above.

6. The Government Order read as 5th paper above stands cancelled.
