ORDER

As per G.O read as 5th paper above, Government have accorded sanction to release an amount of Rs.200 Lakh (Rupees Two Hundred Lakh Only) from Budget Head: XXII-4217-60-051-95(P) of LIFE Mission to Secretary, GCDA, Cochin A/c No.31277968180, SBI Ernakulam South Branch, IFS Code: SBIN0008616 as first instalment of advance to GCDA for constructing LIFE apartments consisting of two blocks in 70 Cents of self-owned land at West Rameswaram, Fort Kochi in Ernakulam District for the rehabilitation of 80 families of P & T colony under LIFE Mission project.

- 2. As per Government Orders read as 1 st & 2nd paper above the amount has to be transferred to PSTSB account of GCDA.
