#### <u>ORDER</u>

Solid and liquid waste must be managed properly in order to protect public health and the environment. The Swachh Bharat Mission 2.0 and AMRUT 2.0 focus on the treatment of liquid waste and protection and conservation of water bodies. The 15th Finance Commission also stipulates that 50% of the LSG grants and 100% of the funds for Urban agglomerations are used for water and sanitation. Kerala which the first major state to achieve ODF status is now struggling with second generation problems of leachate and contamination of water bodies. This poses a serious threat to the public health model of the State which had successfully contained contagious disease outbreaks. This problem is exacerbated by the increasing frequency of extreme weather events that are disrupting the water balance. Immediate action is therefore the need of the hour.

However it is seen that local governments are struggling to come up with viable projects, and even where projects are sanctioned, they are facing stiff local resistance which in many cases effectively kill the project, and by extension, the solution to the problem. The population density, high water table, local resistance and inability to build consensus, lack of access to location specific technologies either conventional or nature based, lack of institutional capability have all contributed to an entrenched reluctance to resolve the problem of liquid waste management. It is important to kickstart<sup>‡</sup> interventions in this very critical area.

A citizen education campaign that can highlight the need for clean water and the scope for addressing its pollutants, particularly liquid waste, both sullage and septage, is to be organised. It has been proposed that this campaign could focus on mapping water bodies in every LSG, grading the level of contamination, and identifying major polluting factors, which of and by itself would generate awareness and sensitivity to the problem facing the State. It would also provide an impetus to local governments to resolve the identified issues of contamination through their upcoming annual plans, thereby creating an opportunity to start tackling the problems of liquid waste and contaminated water bodies. In order to propel the initiative forward, it has been decided to launch a massive campaign involving people's representatives, traders' organisations, voluntary organisations, residents' associations, educational institutions, NSS volunteers, and others, led by the local governments in December 2021- January 2022. It is also proposed to support this initative by developing a shelf of projects that can be undertaken by LSGs to resolve the identified problems arising out of the campaign, through the process of technical consultation with institutions and individuals with domain expertise in liquid waste management.

Therefore, the Government have examined the matter in detail and are pleased to constitute a State Resource Group and Core Organising Committee for conducting the Clean Aquifer (Water body) Campaign .The following are the members of State Resource Group:


