ORDER

As per the G.O read as Ist paper above, Sri.U.V.Jose IAS (Rtd.) has been appointed as Deputy Project Director in the State Project Management Unit of World Bank-AIIB assisted Kerala Solid Waste Management Project (KSWMP) adhering to the ususal terms and conditions applicable to employees on re-employment. Sri.U.V.Jose was working as Special Secretary, LSGD and retired from service on 31.05.2021 AN subsequent to superannuation.

2. Project Director, KSWMP vide letter read as 2nd paper above has reported that the pay of the aforesaid officer has not been fixed. Therefore he requested to fix the pay based on existing terms and conditions applicable to the employees on re-employment.

Government have examined the matter in detail and are pleased to fix the re-employment pay of Sri.U.V.Jose IAS (Rtd.) to Rs. 82,700/- and he is only entitled to the allowances mentioned in G.O (P) No 159/2016/Fin dt 19.10.2016. Along with the re-employment pay, he is entitled to the benefit of;
- DA on re-employment pay shall be admissible as per the rate prevailing in the parent department.
- HRA and CCA if any, applicable from time to time on the pay at the time of retirement and at the rate as admissible in their parent department. It can be calculated taking into consideration the corresponding revised scale of pay of the post from which the pensioner retired.
- He is eligible for pension and admissible DR on pension and eligible for annual increment and not eligible for stagnation increment.
