ORDER

As per letter read as 1st paper above Project Director, KSWMP has requested to additionally authorise an amount of Rs.2,10,00,000/- (Rupees Two Crore Ten Lakh Only) under the head of account 2217-05-800-66 with permission to transfer credit the sanctioned amount into the Special TSB Account No. 701041400000084 maintained at the State Project Management Unit of the KSWMP.

2. As per Government Order read as 2nd paper above the nomenclature of the head of account 2217-05-800-66(PV) has been modified as KSWMP from KUSDP and as per Government Order read as 3rd paper above an amount of Rupees One Crore has been additionally authorised under the head of account 2217-05-800-66. The additional expenditure authorized is to meet the administrative expenses of the State Project Management Unit and other preparatory activities for the implementation of Kerala Solid Waste Management Project (KSWMP).

3. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the project preparation activities for the implementation of Kerala Solid Waste Management Project.

4. Sanction is also accorded to release an amount of Rupees One Crore under the head of account 2217-05-800-66 to KSWMP for meeting the administrative expenses of the State Project Management Unit and other preparatory activities for the implementation of KSWMP with the share of loan assistance from the World Bank for waste management solutions and for setting up sewage-septage treatment plants and sanitation infrastructure in the urban areas of the State subject to the following conditions :

- i. The Controlling Officer of the Head of Account shall take timely steps to regularise the additional expenditure through Re-appropriation of Savings within the Grant before the close of the current financial year.
- ii. The Project Director, KSWMP shall clarify the status of the project advance before further fund requirement.
- iii. The Utilization Certificate shall be furnished to Government in time.

5. Sanction is also accorded to transfer credit the above amount into the Special TSB Account No. 701041400000084 maintained with the Sub treasury Vellayambalam.


