ORDER

An amount of Rs.559 Crore has been earmarked by GoI, for the utilization of State in Health Sector for the year 2021-22 as recommended by 15th Finance Commission, out of which Rs.447 Crore was sanctioned by the National Level Committee. This amount has been allotted to the State Government for implementation through LSGs. An amount of Rs. 202 Crores and Rs.193 Crores has been released to Urban and Panchayat Directorates respectively.

2. Action plan has been formulated and approved for the current year 2021-22. Implementation can be started as the approval of GoI has already been received. In order to facilitate transaction of the Health grants, separate bank accounts have to be opened at the level of every LSG implementing the action plan.

3. In the circumstances, Government are pleased to grant general permission for opening separate bank accounts for each scheme for Local Governments to receive and operate the Fifteenth Finance Commission Health Grant to Local Bodies through the PFMS platform.
