## **ORDER**

The Ministry of Rural Development (MoRD), Government of India had identified Kudumbashree as a National Resource Organization (NRO) for the Start-up Village Entrepreneurship Programme (SVEP). The MoRD had sanctioned, as per the letter read as 2<sup>nd</sup> paper above, an amount of ₹36.00.000/- as the 1<sup>s t</sup> tranche of 1<sup>s t</sup> installment of Central Share for of **SVEP** Project in Koipuram Block implementation Pathanamthitta District & Ettumanoor Block of Kottayam District for conducting baseline and market potential study during the year 2021-22 and as per the letter read as 3<sup>rd</sup> paper above, an amount of ₹14,40,000/- as the 2<sup>nd</sup> tranche of 1st installment of Central Share for implementation of SVEP Project in Vypin Block of Ernakulam District for promotion of enterprise

based livelihoods during the year 2021-22.

- 2) The Executive Director, Kudumbashree, as per his letter read as 4<sup>th</sup> paper above, has requested to release the aforesaid Central shares, which comes to a total of **Rs.50,40,000/-**, from the H/A 2501-06-197-48(25), along with its corresponding State Share of **Rs.33,60,000/-** from the H/A 2501-06-197-48(26) to the Account No. 3343101005271 (IFSC CNRB0003343) maintained at Canara Bank.
- 3) Government have examined the matter in detail. As per the GO read as 5th paper above, sufficient amount has been reappropriated to the separate heads of account for SVEP. In the circumstances, Government are pleased to accord sanction to release a total amount of ₹84,00,000/- (Rupees Eighty four lakh only) as Central share and its matching State share for the implementation of Start up Village Entrepreneurship (SVEP) Project in Kerala for the FY 2021-22 as follows;
