ORDER

As per Government Order read as 3rd above sanction was accorded to Project Director, KSWMP for hiring an electric vehicle from EESL through ANERT and also to execute wet lease agreement (car with chauffeur) with ANERT. Project Director, KSWMP has hired two e-vehicles (Tata Nexon) from ANERT and currently the drivers are engaged by ANERT is charging around Rs.30,000/- (Rupees Thirty thousand only) per month for each driver. One vehicle was hired based on the Government Order read as 1st above without obtaining prior sanction and the other vehicle was hired based on the sanction issued as per Government Order read as 3rd above.

(2) As per Government Order read as 2nd above an amount of Rs. 730/- per day subject to a maximum of Rs.19,710/- (Rupees Nineteen thousand seven hundred and ten only) has been fixed for the drivers engaged on daily wages basis.

(3) As per letters read as 4th paper above, Project Director, KSWMP has informed that considering financial aspects, it would be beneficial if the drivers could be engaged on daily wage basis. It is also informed that the expenditure in this regard can be met from the funds available with KSWMP. Project Director, KSWMP has requested to grant permission for engaging two drivers on daily wage basis in the State Project Management Unit of KSWMP for the two vehicles hired from ANERT and also requested to ratify the action in having hired one vehicle from ANERT without prior sanction.

(4) Government have examined the matter in detail and are pleased to accord sanction to Project Director, KSWMP to engage two drivers on daily wage basis in the State Project Management Unit of KSWMP for the two vehicles hired from ANERT. The action in having hired one vehicle from ANERT without prior sanction is also ratified.


