### **ORDER**

As per the letters read as 1st, 2nd and 3rd papers above, the Ministry of Rural Development (MoRD), GoI had sanctioned a total amount of ₹36,54,55,000/- (General component - ₹15,24,31,000/-, SCP component - ₹12,58,63,000/- and TSP component - ₹8,71,61,000/-) as the 2<sup>nd</sup> tranche of 1<sup>st</sup> installment of Central share for the implementation of NRLM/Ajeevika for the year 2021-22.

2) Being the implementing agency of NRLM/Ajeevika Scheme in Kerala, the Executive Director, Kudumbashree, as per the letter read as 4th paper above, has requested to release the Central share sanctioned along with matching State share, which comes to a total amount of ₹ 60,90,91,667/- (Central Share - ₹ 36,54,55,000/- and State Share ₹ 24,36,36,667/-), from the current year's Budget allocation to them.

3) Government have examined the matter in detail. As per the Budget allocation of NRLM/Ajeevika for the year 2021-2022, the total balance fund available for releasing TSP component under the H/A 2501-06-796-99 (1&2) is ₹ 3,71,85,000/- only (₹ 2,23,11,000/- as Central share and ₹1,48,74,000/- as State share). In the above circumstances, sanction is accorded to release a total amount of ₹ 50,10,08,334/- (Rupees Fifty Crore Ten Lakh Eight Thousand Three Hundred and Thirty Four only) to Kudumbashree as the 2<sup>nd</sup> tranche of 1<sup>st</sup> installment of Central share and its corresponding State share for the implementation NRLM/Ajeevika for the year 2021-2022, as detailed in the table given below.
