ORDER

As per the orders read as 1st and 2nd papers above, Government have given AS for 2 works of Kannur Corporation in Water Supply Sector. As per the letter read as 4th paper above, the Mission Director AMRUT has informed that the matter has been placed in the 29th SHPSC for approval and the Committee decided as follows:

Details of the Works and decision of SHPSC

1. Water Supply sector- Puzhathi-Rehabilitation of existing old distribution networks, valves, house service connections and interconnections in Kannur Corporation SAAP 2015-16,2016-17 – AS for Rs.16.9 Cr., vide G.O(Rt) No. 3170/ 2017/ LSGD dated 23/02/2017. Additional amount to the tune of Rs.1.95 Cr. is required due to increase in road restoration charges. The additional amount may be met from savings in SEW/SEP Sector [Work: Providing de-centralised sewerage network with STP in Old

Kannur Municipal Area. AS issued as per G.O. (Rt.) No. 5/2018/LSGD dated 01/01/2018]. The SHPSC decided to revise the AS of the work to Rs.18.85 Cr. from Rs.16.9 Cr., due to the increase in road restoration cost subject to the condition that the Additional Amount of Rs.1.95 Cr. shall be met from the AS to TS savings in the SEW/SEP Sector.

2. Water Supply Sector –Providing New House Service Connections (4950 Nos.) Including Water Meter – AS for Rs.2.92 Cr., vide GO(Rt) No. 2850/2019/LSGD dated 16/12/2019. The additional amount may be met from savings in SEW/SEP Sector [Work: Providing decentralised sewerage network with STP in Old Kannur Municipal Area. AS issued as per G.O. (Rt.) No. 5/2018/LSGD dated 01/01/2018]. The SHPSC decided to approve the utilization of an amount of Rs.2.92 Cr. from the TS savings of Sewerage & Septage Sector in place of 22nd SHPSC's decision to utilize the savings in Water Supply, Storm Water Drainage and Urban Transport Sectors.

2. Government have examined the matter in detail and are pleased to revise the administrative sanction for work of Kannur Corporation in Water Supply Sector "Puzhathi–Rehabilitation of existing old distribution networks, valves, house service connections and interconnections in Kannur Corporation SAAP 2015-16,2016-17" to Rs.18.85 Cr. from Rs.16.9 Cr., subject to the condition that the additional amount of Rs.1.95 Cr. shall be met from the AS to TS savings in the SEW/SEP Sector and also are pleased to approve the utilization of an amount of Rs.2.92 Cr. from the TS savings of Sewerage & Septage Sector in place of 22nd SHPSC's decision to utilize the savings in Water Supply, Storm Water Drainage and Urban Transport Sectors for the work "Providing New House Service Connections (4950 Nos.) Including Water Meter" of Kannur Corporation in Water Supply Sector.
