### ORDER

Government vide Order read as 1<sup>st</sup> paper above approved 53 bridges/culverts for reconstruction under Rebuild Kerala Initiative by Project Management Unit, RKILSGD. Administrative Sanction was accorded vide Government Order read as 2<sup>nd</sup> paper above for soil investigation works of 46 bridges/ culverts included for reconstruction under Rebuild Kerala Initiative.

Project Director, PMURKI vide letter read as 3<sup>rd</sup> paper above reported that the in-house design capability of the PMU is limited and designing of all the bridges cannot be taken up by PMU. Project Director has proposed to engage consultants for designing of 31 bridges to complete the projects in a time bound manner. The cost estimated for engaging Consultants for 31 bridges is Rs.72.10 lakhs.

Government have examined the matter in detail and are pleased to accord Administrative Sanction for engaging Consultants for designing of the 31 bridges at an estimated cost of Rs.72.10 lakhs incurring the expenditure from the project fund sanctioned to Project Management Unit under the Head of Account 5475-00-115-94-01. PMU shall engage consultants, through a transparent and competitive process, for investigation, design, preparation of drawings, detailed estimate and preparation of DPRs of the 31 bridges at NRIDA rates, subject to the maximum consultancy charges allowed as per Government Order read as 5<sup>th</sup> paper above.


