

## **ORDER**

As per the Government Order read as 1 st paper above, Rs.45,34,15,733/- and Rs.19,09,31,592/- were released to KURDFC Ltd for payment of quarterly interest that was due in the month of November, 2021 in respect of loan availed from HUDCO for LIFE Mission scheme. Now as per letter read as 2<sup>nd</sup> paper above, KURDFC Ltd, has reported that the quarterly interest payment on HUDCO Loans (for Rural & Urban) becomes due in the month of February 2022. According to KURDFC the interest amounts payable are Rs.43,77,27,319/- (for Rural) and Rs.18,63,94,944/- (for Urban). During the current Financial Year an amount of Rs. 160 crore is provided under the head of account 2515-00-102-30 (PV) Rural and an amount of Rs. 55 crore is provided under the head of account 2217-80-800-62 (PV) Urban as interest subsidy to KURDFC towards the loan availed from HUDCO for the implementation of LIFE mission scheme.

2. In the circumstances reported above, the proposal from KURDFC is recommended by CEO LIFE Mission as per the letter read as 3<sup>rd</sup> paper above and requested to release an amount of Rs. 43,77,27,319/- under the head of account 2515-00-102-30 (PV) Rural and Rs.18,63,94,944/- under the head of account 2217-80-800-62 (PV) Urban to KURDFC Ltd for the payment of the above interest by transfer-crediting the amounts to their bank account No. 37920881126 (Rural Out) and No. 37922795767 (Urban Out) respectively with State Bank of



India, Vazhuthacaud Branch, IFSC: SBIN0070033. An additional expenditure to the tune of Rs.24,00,70,000/- in the head of account 2515-00-102-30 (PV) Rural and Rs.18,63,95,000/- in the head of account 2217-80-800-62 (PV) Urban has been authorised vide G.O. read as 4<sup>th</sup> and 5<sup>th</sup> papers above

3. Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs. 43,77,27,319/- (Rupees Forty Three Crore Seventy Seven Lakh Twenty Seven Thousand Three Hundred and Ninteen Only) from the head of account 2515-00-102- 30 (PV) Rural and Rs. 18,63,94,944/- (Rupees Eighteen Crore Sixty Three Lakh Ninety Four Thousand Nine Hundred and Forty Four only) from the head of account 2217-80-800-62 (PV) Urban for the payment of the quarterly interest on HUDCO Loans (for Rural & Urban) which becomes due on February 2022 and to transfer-credit the amounts to the bank account No. 37920881126 (Rural Out) and No. 37922795767 (Urban Out) respectively of KURDFC with State Bank of India, Vazhuthacaud Branch, IFSC:SBIN0070033.
