### ORDER

As per letter read as 1st paper above Government of India have sanctioned 1st tranche of Central Share for the financial year 2021-22, amounting to ₹2,74,71,000 (Rupees Two Crore Seventy Four Lakh and Seventy One Thousand only) for implementation of the projects under Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana 2.0 (WDC-PMKSY 2.0) in Kerala. Corresponding State Share (40%) of the Central release comes to ₹1,83,14,000/- (Rupees One Crore Eighty Three Lakh and Fourteen Thousand only). As per the letter read as 2nd paper above, the Commissioner for Rural Development Department has submitted proposal for the release of the aforesaid Central Share and the matching State Share.

2.Government have examined the matter in detail and are pleased to accord sanction to release a total amount of ₹4,57,85,000/- (Rupees Four crore Fifty seven lakh and Eighty five thousand only) towards the 1st tranche of Central Share for the financial year 2021-22 along with its matching State Share, for implementation of the projects under WDC-PMKSY 2.0 in Kerala, as detailed below;
