ORDER

Executive Director, IKM, as per the note read as 2nd paper above, has submitted a proposal citing requirement of additional man power in completing the development of the integrated Local Governance Management System (ILGMS) application in a time bound manner and for taking up other externally funded projects. As per the proposal the three broad categories of projects that requires manpower are:

- ILGMS for Urban Local Bodies (Integrated application)
- Restructuring existing ILGMS into Cloud Native Application (Micro Service Architecture)
- Development and enhancement of external projects (with separate funding)

(2) Executive Director submitted that the following additional posts are required in IKM for taking up the emergency commitments in connection with urban roll out of ILGMS as well as other externally funded projects and that resources need to be recruited temporarily on short-term contract basis for a period of 1 year to maximum period of 2 years.


