ORDER

Government, vide Order read as 1st paper above, have accorded Administrative Sanction for the project, 'Setting up of an Integrated Plastic Waste Management Facility (IPWMF) at Kunnamthanam in Pathanamthitta District', at an estimated cost of Rs4.56 crore under Rebuild Kerala Initiative. In addition to this, lease premium for the land payable to KINFRA is Rs.1.37 crore.

Managing Director, Clean Kerala Company Ltd vide letter read as 2nd paper above informed that, by accepting the request made by President, Pathanamthitta District Panchayat, the Board of Directors of the Company has decided to execute the Project in association with the District Panchayat. Managing Director informed that subject to Government approval, the Pathanamthitta District Panchayat is willing to invest Rs.2Crores for the Project in two installments and that detailed deliberations are being pursued to derive conditionalities of the collaboration and the mechanisms for coordinating and monitoring the Project. Managing Director reported that the proposed convergence with the local body would instill participative nature to the project and that it would facilitate more optimum utilisation of RKI funds. Accordingly, Managing Director, Clean Kerala Company Ltd requested to accord sanction to execute the Project as a joint venture with Pathanamthitta District Panchayat and to utilize fund provided by the Pathanamthitta District Panchayat for the Project.

Government examined the matter in detail and are pleased to accord permissive sanction to execute the Project, viz, 'Integrated Plastic Waste Management Facility (IPWMF) at Kunnamthanam', as a joint venture of Clean Kerala Company Ltd and Pathanamthitta District Panchayat, subject to the condition that the aims, objectives, environmental safeguards and

operational modalities envisaged in the Administrative Sanction are conformed to, and that the roles and responsibilities of each stakeholder in the joint venture is clearly laid out and observed.
