As per the letter read as 2nd paper above, the Mission Director, AMRUT has requested the Government to transfer credit Rs.191,39,14,000.00 inclusive of CA and matching state share and proportionate into the PSTB account bearing No. 363, maintained by Mission Director, AMRUT for Centrally sponsored Schemes with the Sub Treasury, Vellayambalam and transfer credit to the PFMS account No.6424109855 maintained by the Mission Director AMRUT in the Indian Bank, Thycad Branch.
- 3. Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs.191,39,14,000/ (Rupees One hundred Ninety One Crore Thirty Nine Lakh Fourteen Thousand only) (Central share along with State share) as part payment of 3rd installment of the CA and SA under AMRUT for SAAPS I and SAAPS III into the PSTB account bearing No. 363, maintained by

Mission Director, AMRUT for Centrally Sponsored Schemes with the Sub Treasury, Vellayambalam and transfer credit to the PFMS account No.6424109855 maintained by the Mission Director AMRUT in the Indian Bank, Thycad Branch, IFS Code IDIB000T021 from the Head of account as detailed below:
