ORDER

As per the letter read as 4th paper above, an amount of ₹50,10,08,334/- out of the total amount of ₹60,90,91,667/- to be released as 2nd tranche of 1st installment of Central and State Share for the implementation NRLM/Ajeevika, for the year 2021-2022. Due to shortage of fund under TSP head, a total amount of ₹10,80,83,333/- could not be released. Hence, as per the letter read as 5th paper above, the Executive Director, Kudumbashree has requested to release the balance amount of Central share and State share under TSP component.

2) Government have examined the matter in detail. As per 6th paper

above a total amount of ₹10,80,84,000/- (Central share- ₹6,48,50,000/-, State share- ₹4,32,34,000/-) has been authorised as additional expenditure. In the circumstances, Government are pleased to accord sanction to release the balance amount ₹10,80,83,333/- (Rupees Ten crore Eighty lakh Eighty three thousand Three hundred and Thirty three only) towards Central and State Share under TSP component of 2nd tranche of 1st installment for the year 2021-2022, to Kudumbashree for the implementation NRLM/Ajeevika in Kerala, as detailed below;
