ORDER

As per GO read as 1st paper above sanction was accorded for the implementation of Kerala Solid Waste Management Project (KSWMP) and as per GO read as 2nd paper above, Project Implementation manual (PIM) has been approved which provides detailed guidelines and operational mechanisms for the project. As per para 3.2.5 of the PIM the KSWMP has to hire a Project Management Consultant (PMC).

2. As per GO read as 3rd paper above Government have approved the Request for Expression of Interest for publication in line with the approval of World Bank for the selection of Project Management Consultant for KSWMP.

3. As per GO read as 4th paper above an Evaluation Committee has been reconstituted for evaluating Expression of Interests (EOIs) and Request for Proposals (RFPs) received in connection with the selection of various consultancy services for

Kerala Solid Waste Management Project.

4. As per letter read as 5th paper above, Project Director, KSWMP has informed that the Committee evaluated the REOIs and RFPs received and after the evaluation, the Committee submitted the combined Technical & Financial Evaluation Report for further action including negotiation of the contract as per World Bank guidelines and award. It is also reported that among the six consultancy firms submitted financial bid, the combined score obtained by M/s KPMG Advisory Services Pvt Ltd in association with Andhyodaya - Sub consultant, MOSAIC Advanced Solutions LLP Sub-consultant was the highest and as such it is decided to assign the Project Management Consultancy of this project to this firm. Incidentally the financial bid offered by the same firm was also the lowest. The next stage of the selection process is award of contract and signing of agreement with the firm. Project Director, KSWMP has requested to give consent to KSWMP for signing the agreement with PMC.

5. Government have examined the matter in detail and are pleased to accord sanction to KSWMP to enter into agreement with PMC, subject to the condition that the contents shall be verified by the Project Director and ensure that it is in accordance with the objectives of the Project - before signing the agreement.
