ORDER

The Chief Engineer, Local Infrastructure Development & Engineering Wing, vide the letter read above, forwarded the application submitted by Sri.Krishnakumar.S, Assistant Executive Engineer, who is now serving on deputation basis as Technical examiner in the Finance Inspection Wing, to incorporate his prior service with the Government of India as Junior Engineer (Civil) with the Civil Construction wing of the All India Radio & Doordarshan for the calculation of his pension in State service.

Government have examined the matter in detail. As per Note 2 below Rule 11 Part III KSRs, employees of the State Government Departments who left the former service in Central Government for taking up appointment in State Government Departments will be allowed to reckon their prior service for all pensionary benefits along with the service in the State Government Department. The All India Radio & Doordarshan is under Department of Information & Broadcasting which belongs to the Union Ministry under the First Schedule of Govt of India (Allocation of Business Rules 1961). As per the service particulars, the incumbent entered into the service of AIR on 08.05.1989 and left AIR on 31.10.2006 and joined the State service on 01.11.2006 i.e within the joining time.

In the above circumstances, the previous Central Service of Krishnakumar.S, Assistant Executive Engineer for the period from 08.05.1989 to 31.10.2006 is reckoned as qualifying service for pensionary benefits along with his State Service and orders issued accordingly.
