ORDER

As per the letter read above Cheif Executive Officer, Life MIssion has informed that Rs. 2,540,250,340/- was resumed from PSTSB A/c. No. 799012700001688 of Life Mission on 31/03/2022 as detailed below:

2. It was also informed that the Salary and and other administration expenses are met from the above account and only Rs. 10 lakhs is left in the above account which is not even sufficient to meet the salary expenses. Further an amount to the tune of Rs.50 crore is urgently

required to meet the payment of work bills of various Life Towers, which are scheduled to be inaugurated in the month of May 2022 and hence the above amounts resumed may be immediately refunded to the above heads. It is also requested that the amount resumed from PSTSB as detailed above may urgently be refunded to LIFE MISSION for the smooth implementation of LIFE MISSION programmes.

Government have examined the matter in detail and are pleased to release an amount of Rs. 1,97,10,394/- (Rupees One crore Ninety seven lakhs Ten thousand three hundred and ninety four only) from the H/A 4515-00-102-49 for meeting the administrative expenses, Rs.50,61, 03,189/- (Fifty crore Sixty one lakhs three thousand one hundred and eighty nine only) from the H/A 4515-00-102-49 for Total Housing Scheme Rural Life Parpida Mission(Total of Rupees 52,58,13,583/-) and Rs. 24,61,36,757/-(Rupees Twenty Four Crore Sixty One Lakh Thirty Six Thousand Seven Hundred and Fifty Seven only) from the Head of Account 4217-60-051-95 for Total Housing Scheme Urban Life Parpida Mission.
