## **ORDER**

As per GO read as 1<sup>st</sup> paper above Kerala Urban Service Delivery Project (KUSDP) has been constituted for allotting World Bank funds to the Urban Local Bodies and as per GO read as 2<sup>nd</sup> paper above the name of the project has been renamed as Kerala Solid Waste Management Project (KSWMP)

- (2) The Kerala Solid Waste Management Project is being implemented in a wider scope with additional financial and technical support for the effective and focused attention to the solid waste management of 93 Urban Local Bodies in the State, over the expected Project period of 6 years. The project comprising the following 3 components.
- Component 1: Institutional Development, Capacity Building and Project Management.
- Component 2: Grant support to ULBs for Solid Waste Management.
- Component 3: Development of Regional SWM facilities.
- (3) Project Director, KSWMP as per letter read as 3<sup>rd</sup> paper above has reported that the components can be planned and implemented only through the close coordination of various agencies within and connected to the Local Self Government Department. To facilitate inter
