ORDER

As per Section 27 of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005, Government of India have issued detailed instructions to the State Governments to establish the Office of the Ombudsman for redressal of Grievances and disposal of complaints relating to implementation of the Mahatma Gandhi NREGS. As per the Government order read as 1st paper above, the Selection Committee for preparing and recommending to Government, the ranked panel of persons found suitable for appointment as Ombudspersons in accordance with the instructions issued by Government of India was reconstituted.

- 2.As per the Government order read as 2nd paper above, Government appointed Ombudspersons in the 10 districts of the State as per the recommendation of the Selection Committee and the Ombudspersons appointed in the districts of Eranakulam, Thrissur, Malappuram and Kozhikkode were given full additional charge of Ombudspersons in the districts of Kasargod, Palakkad, Wayanad and Kannur respectively.
- 3.Fresh notifications had been issued later for appointment in the above four districts and final rank list prepared by the selection committee has been notified as per the Government order read as 3rd paper above.

4.In these circumstances, Government of Kerala in exercising the powers conferred under Section 27 of MGNREG Act 2005 and in accordance with the instructions issued by Government of India are pleased to appoint the following persons as Ombudspersons in the following districts of the State noted against their names under MGNREGS for redressal of grievances and disposal of complaints relating to implementation of MGNREG Act and the Schemes made under the said Act by the State, from the ranked panel notified as per Government order read as 3rd paper above.

- 6. The persons appointed shall take charge from the Ombudspersons holding additional charge in the District concerned, immediately on receipt of this order after completing all necessary formalities and shall

send a joining report to the undersigned in due course.
