**ORDER**

Project Director, KSWMP as per letter read as 1<sup>st</sup> paper above, requested to release an amount of Rs. 1232.76 lakhs under the head of account "2217-05-800-66-KSWMP" for the first three months of the current financial year, 2022-23. Project Director, KSWMP informed that the fund required is for meeting the administrative & establishment expenses, infrastructural expenses, Project Management Consultancy (PMC) Charges, Interior and furniture works, Training Awareness Generation/ Information, Education, Communication etc. for the first three months of the current financial year, 2022-23.

(2) Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs. 6 crore (Rupees Six Crore only) to KSWMP from the head of account "2217-05-800-66-KSWMP" out of which Rs.4.5 Crore from "2217-05-800-66-01 (EAP share 70%) and Rs.1.5 Crore from "2217-05-800-66-01 (State share 30%) for meeting the administrative & establishment expenses. Sanction is also

accorded to transfer credit the amount into the Special TSB Account No. 701041400000084 of the KSWMP maintained at the Sub Treasury, Vellayambalam. Project Director, KSWMP is directed to ensure proper sanction orders before meeting the claims towards vehicle lease charge, advertisement charges, repair and maintenance, purchases, Training / awareness generation, infrastructural expenses, PMC charges etc.
