ORDER

As per the report of Vigilance &Anti-Corruption Bureau in connection with a Vigilance surprise check at Kodungallur Municipality, Government initiated disciplinary action against Sri. A P George,Sri. Gopalakrishnan,and Sri. Rajeev B, the officials of Kodungallur Municipality under KCS (CC&A) Rules 1960.

- 2. Sri. A P George, Sri. Gopalakrishnan, and Sri. Rajeev B, the officials of Kodungallur Municipality filed OA(E) 1476/2020, OA(E) 1509/2020 and OA(E) 1592/2020 before the Hon'ble Kerala Administrative Tribunal with a prayer to direct the first respondent to finalise their disciplinary action urgently.
- 3. As per order dated 09.02.2021 in OA(E) 1476/2020 filed by Sri. A P George, the Hon'ble Tribunal directed to the first respondent to pass final orders in the disciplinary proceedings against the applicant within three months from the date of receipt of the copy of the order.
 - 4. And as per order 09.02.2021 in OA(EKM) No.1509/2020, filed by

- Sri. Gopalakrishnan, the Hon'ble Tribunal directed the first respondent to finalise the disciplinary proceedings against the applicant without further delay and at any rate within a period of three months from the date of receipt of a certified copy of the order.
- 5. Also as per order dated 19.02.2021 in OA(E) 1592/2020, filed by Sri. Rajeev B, the Hon'ble Tribunal directed to the first respondent to finalise the disciplinary proceedings against the applicant without further delay and at any rate within a period of two months from the date of receipt of a certified copy of this order. On finalization of the proceedings, the respondents shall ensure that the pensionary benefits due to the applicant are disbursed without further delay, at any rate, within a period of six weeks there from.
- 6. Accordingly Government examined the disciplinary case in detail and after completing all the procedures under KCS (CC&A) Rules 1960, finalised the disciplinary action initiated against Sri. A P George, Sri. Gopalakrishnan, and Sri. Rajeev B, the officials of Kodungallur Municipality as per order read as 4th paper above.
- 7. In the circumstances the Tribunal orders read as 1st, 2nd and 3rd paper above are complied.
