ORDER

Government have accorded sanction for constructing LIFE apartments consisting of two blocks in 70 Cents of self-owned land at West Rameswaram, Fort Kochi in Ernakulam District for the rehabilitation of 82 families of P & T colony under LIFE Mission project to Greater Cochin Development Authority vide Government Order read (1) above and have accorded administrative sanction for an amount of Rs. 14,61,69,100 as per Government Order read (2) above. An agreement was executed between GCDA and Life Mission on the condition that an amount of Rs. 903 Lakhs shall be given to GCDA for this work by LIFE Mission and this amount shall be released in five installments according to progress of work and second installment has to released completion of 25% of work.

2. The administrative sanction for the project has been issued by the Government for an amount of Rs. 14,61,69,100 as per order read as second paper above. Technical sanction for the work was issued by the Technical Committee on 28.07.2020. As per the Agreement executed between GCDA and LIFE Mission on 20.01.2021, vide third paper above, an amount of Rs. 903 Lakh shall be given to GCDA for this work by LIFE Mission which shall be released in five installments according to progress of work. An amount of Rs.200 Lakh has already been sanctioned as 1st installment as per order read as fourth paper. Now, GCDA has requested

for release of second installment for Rs.200 lakh which was forwarded to Government as per letter read as fifth paper above. The District Engineer LIFE Mission has reported that more than 25% of estimate amount of work has been completed. As per agreement second installment of Rs. 200 Lakh (Rupees Two Hundred Lakh Only) is to be released to GCDA on completion of 25% of work.

3.Government have examined the matter in detail and are pleased to accord sanction releasing an amount of Rs 200 lakh (Rs Two Hundred lakh) from Budget Head: XXII- 4217-60-051-95 (P) of LIFE Mission to the Secretary, GCDA, Cochin A/c No.31277968180. SBI- Ernakulam South Branch, IFSC Code: SBIN0008616, as Second installment towards the construction of LIFE Apartments at West Rameshwaram, Fort Kochi in Ernakulam District for the rehabilitation of 80 families of P & T colony under LIFE.
