ORDER

Government of India have issued an advisory to all states that at least 75 water bodies or 'Amrit Sarovars' may be created or rejuvenated in every district of the country, so as to ensure availability of water, both surface and under-ground, as part of the 'Azadi Ka Amrit Mahotsav' celebrations.

2. To achieve the above objective, the 'Mission Amrit Sarovar' was launched by the Hon'ble Prime Minister on 24 April 2022. As per the guidelines regarding the Mission, a substantial number of structures have to be created by August 15, 2022 and the whole Mission is to be completed by the end of Amrit Varsh i.e.by August 15, 2023.

3. The guidelines further envisage setting up of a State-level committee chaired by the Chief Secretary to oversee the implementation of the project in all the districts of the state, and to ensure vertical and horizontal coordination .

4. Government have examined the matter in detail and are pleased to

constitute a State-level Monitoring Committee to oversee and monitor the implementation of 'Mission Amrit Sarovar' with the following composition:
