ORDER

Government of India vide letter read as 3rd paper above have released an amount of ₹5,83,42,07,000/- (Rupees Five Hundred Eighty Three Crore Forty Two Lakh and Seven Thousand only) to the State Government of Kerala being the 1st installment of 1st tranche of central assistance towards material and administrative contingency for implementation of MGNREGA for the financial year 2022-23. This amount includes ₹5,10,35,70,000/- as Material component and ₹73,06,37,000/- as Administrative component. The Mission Director, MGNREGS State Mission, vide letter read as 4th paper above, has

submitted a proposal for release of the Central share received along with its corresponding State share. The Mission Director has also requested to release an amount of ₹1.33 lakh towards the shortage in the release of matching State share during previous year as instructed by Government of India vide letter read as 2nd paper above.

2. Government have examined the matter in detail and are pleased to accord sanction for releasing an amount of ₹5,83,42,07,000/- (Rupees Five Hundred Eighty Three Crore Forty Two Lakh and Seven Thousand only) being the 1st installment of 1st tranche of Central assistance received towards Material and Administrative components for implementation of MGNREGA for the financial year 2022-23 along with matching State share of Material component ₹1,70,11,90,000/- (Rupees One Seventy Crore Eleven Lakh and Ninety Thousand only) for the financial year 2022-23. Sanction is also accorded to release the shortage in the matching State share released during previous year ₹1,33,000/- (Rupees One Lakh and Thirty Three Thousand only). The details of funds release and corresponding heads of account are as shown below:
