ORDER

Smt.Anuja.A.S. (Retired Joint Director) joined as Municipal Secretary Grade III on 15.12.2000 and promoted as the Corporation /Additional Corporation Secretary on 13.11.2013.Her probation in the Cadre of the Corporation /Additional Corporation Secretary was declared as satisfactorily completed with effect from 13.05.2014 as per Government order read as 1st paper above.But she was promoted to the next higher post of the Joint Director , only on 29.05.2020 as per the reference 2nd cited.

Anuja A S ,Retired Joint Director has submitted a review petition read as 3rd paper above for sanctioning notional promotion to the post of Joint Director as her probation in the Cadre of the Corporation/Additional Corporation Secretary was declared as satisfactorily completed with effect from 13.05.2014 vide G.O.Rt)No.2610/2015/LSGD dated 24.08.2015 and the disciplinary case for major penalty was finalised by exonerating her from all the charges imposed against as per Government order read as 4th above.

Smt.Anuja.A.S. claimed that she was excluded from the Select List for appointment to the post of Joint Director for the year 2017 prepared by the DPC (H) of the Urban Affairs Department held on 27.03.2017 and 27.09.2017 for the reasons that disciplinary action for major punishment initiated against her vide memo of charges No.EU1/189/15/LSGD . She has reported that there is also a minor punishment vide memo of charges No. EU1/12831/15/LSGD dated 03.12.2015 pending against her .The DPC (H) for the year 2017 considered all the officers having minor disciplinary cases and was included in the Select List.

Government have examined the matter by placing the same before the Adhoc DPC(H) of Urban Affairs held on 19.04.2022.DPC (H) of the Urban Affairs Department held on 27.03.2017 and 27.09.2017 excluded her name for the reasons that disciplinary action for major punishment initiated against her vide memo of charges No.EU1/189/15/LSGD But later the disciplinary action was finalised by exonerating her from all the charges imposed against her vide G.O. (Rt) No.508/2019/LSGD dated 05.03.2019 and hence she was eligible for including in the Select List prepared by the DPC(H) for the year 2017 held on 27.03.2017. She was not included in the select list prepared by the DPC (H) 2019 held on 02.09.2019 due to the reason that the check period for her punishment of one year is up to 03.04.2020.Her immediate junior Shri. Nizarudeen was included in the Select List for promotion to the post of Joint Director prepared by the DPC(H) 2017 held on 27.03.2017 and published vide GO(P)No. 20/2017/LSGD dated 30/03/2017and was promoted on 22.04.2017 to the post of Joint Director in the one of the three existing vacancy .

The Select List for promotion to the post of Joint Director prepared by the DPC (H) 2017 held on 27.03.2017 and published vide GO(P)No. 20/2017/LSGD dated 30/03/2017 which was revised vide GO(P) No 16/2022/LSGD dated 10/02/2022 is again revised and published videGovernment order read as 8th paper by restoring the position of Anuja A S.above the name Shri. Nizarudeen as Sl No (A) above the name of Shri. Nizarudeen.

In the above circumstances Government are pleased to grant notional promotion to Smt.Anuja A S to the post of Joint Director wef 22.04.2017,the date of promotion of his immediate junior,Shri.Nizarudeen as per the Rule 23(c) of Part I KSRs.
