## **ORDER**

As per the Government Order read 1st above Shri.Subash P.K was appointed as Municipal Secretary Grade-III and he joined duty on 02/07/2018 FN. The probation period in the cadre of Municipal Secretary Grade III is two years continuous period of service within a period of three years. The Principal Accountant General (A&E) reported that Shri.Subash P.K has not availed any leave other than casual leave during the probation period. As per G.O (Rt) No.3151/2018/LSGD dated 15.12.2018 he has been granted 15 days Commuted Leave. Hence the period of probation in respect of Shri.Subash P.K, Municipal Secretary Grade III is from 02/07/2018 to 16/07/2020. He has acquired the prescribed qualification of passing departmental test for declaration of probation.
